- **2.** OPEN PUBLIC SESSION Chairman Thazhampallath opened the Public Session at 5:33 p.m. No one wished to speak.
- 3. CLOSE PUBLIC SESSION Chairman Thazhampallath closed the Public Session at 5:34 p.m.

4. APPROVAL OF MINUTES

5. OLD BUSINESS

a. Project update: Paul Morin, Landmark Architects, P.C. informed the committee there will be no additional fee to relocate the gas line, and should be completed by the end of November. Eversource will also change the meter. He also reviewed the dollar amounts discussed in the October 13, 2020 meeting in regard to the suggested 10% contingency. After reviewing the numbers, there is a contingency of 9.7%, making the project short by .3%. He informed the committee it may become an issue with the State of Connecticut when reviewing the documents for final approval.

Enterprise Builders, Inc. would like to begin the permit process, however, they have not received an award letter from the City of Middletown. Chief Howley and Chairman Thazhampallath will pursue the possibility of obtaining a letter of intent/commitment with Donna Imme, Purchasing and Joe Samolis, Planning, Conservation and Development.

6. NEW BUSINESS

- **a.** Project finances Chief Howley reiterated we will not know if the 9.7% contingency is an issue until the State of Connecticut reviews the project finances.

Chief Howley and Chairman Thazhampallath to pursue with the City of Middletown.
