NOTICE OF REFERENDUM

South Fire District June 17, 2025

At a referendum of the South Fire District of the City of Middletown, on Tuesday, June 17, 2025, the following questions will be submitted to qualified registered voters of the district:

Question 1: Shall the proposed budget for fiscal year July 1, 2025 – June 30, 2026 of \$8,072,855 with a mill rate of 5.311 for real estate and personal property, as recommended by the South Fire District of the City of Middletown, be approved?

Question 2: Shall the South Fire District By-Laws be revised in accordance with the recommendations of the By-Laws Review Committee, and approved by the Board of Fire Commissioners?

(Note: There will be no motor vehicle property tax for fiscal year 2025/2026 due to the City of Middletown's Common Council approval of a 31.7 mill rate and the State of CT motor vehicle 32.46 mill rate cap.)

Voting will take place between the hours of 8:00 a.m. and 8:00 p.m. at the firehouse, 445 Randolph Road, Middletown, CT. Absentee ballots are available to qualified registered voters of the South Fire District.
