# Board of Fire Commissioners SPECIAL MEETING MINUTES Wednesday, May 18, 2022 – 6:30 p.m.

**Present**: Commissioners Kleckowski, Giuliano, Penney, Thazhampallath (arrived at 6:57 p.m.), and Pessina; Deputy Chief Jacobs

#### 1. CALL TO ORDER

Chairwoman Kleckowski called the meeting to order at 6:32 p.m.

#### 2. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

#### 3. PUBLIC SESSION

Chairwoman Kleckowski opened the public session at 6:33 p.m. There were no members of the public present.

#### 4. CLOSE PUBLIC SESSION

Chairwoman Kleckowski closed the public hearing at 6:33 p.m.

MOTION to recess the meeting pending the arrival of Commissioner Thazhampallath by Comm. Giuliano/Comm. Pessina. Unanimously approved. The meeting recessed at 6:35 p.m.

Chairwoman Kleckowski called the meeting back to order at 6:41 p.m.

#### 5. BUDGET REVIEW

\$521,885 has been added to "Income," representing the funds the district will receive from the State Motor Vehicle Fire District Grant. There were no changes to the expenditure lines.

### 6. ADOPT BUDGET/SET MILL RATE FOR FISCAL YEAR JULY 1, 2022 – JUNE 30, 2023

**MOTION** to adopt the budget as published in the draft as of May 12, 2022 and set the mill rate at 5.555 mills by Comm. Giuliano/Comm. Pessina.

Commissioner Thazhampallath arrived at 6:57 p.m.

Commissioner read into the record a statement. The statement is attached to these minutes.

**MOTION** to amend the motion to offer opportunities for cost reduction to the budget. Commissioner Giuliano called *point of order* stating a suggestion to reduce the mill rate would also have to include a suggested reduction in expenditures so the numbers would match. Commissioner Penney withdrew his motion. Commissioner Giuliano called the question, seconded by Commissioner Pessina. Voting was as follows:

The motion to set the date for the budget referendum for Tuesday, June 14, 2022 from 6:00 a.m. – 8:00 p.m. was unanimously approved.

### 8. APPROVAL OF REFERENDUM REMINER POSTCARDS

MOTION to approve the postcard after adding the correct numbers by Comm. Giuliano/Comm. Pessina.

After debate regarding the mailing list for the postcards, Commissioner Pessina called the question. Commissioner Penney seconded the motion. Unanimously approved.
